INFORMATION ABOUT THE PLEDGER

- The Account Holder/Pledger would need to state his/her/Institution's Name and ABLAMC Account No. and CNIC / Passport No. (in case of Individual)
- 2. The Title of Account of the Principal Account Holder/Investor is required.

DOCUMENTS REQUIRED FOR PLEDGE

Pledgor/Unit Holder(s) is/are required to attachthe following attested documents.

- 1. Units Certificates, if issued.
- 2. Board Resolution authorizing Pledge (in case of other than individuals) or Power of attorney.
- 3. List of Authorized Sigatures with Specimen Signatures of Pledgee.

Registrar/Transfer Agent will send an account statement exhibiting Units blocked in favour of Pledgee to the Pledger as proof of units being pledged in favour of Pledgee.
