- Copy of Zakat Affidavit (Only in case if "No" is selected in Zakat Deduction column) 3.
- Tax Exemption Certificate (Only in case if "Yes" is selected in Tax Exemption Column) 4.
- For Joint account holders of CNIC/Passport No. (for foreigners only) 5.
- Copy of CNIC of Nominee (Optional) 6.

- Cash shall not be accepted. 1.
